Your 2024 Retiree Benefits and More (Continued)

NEW- Enroll and Make Changes ALL YEAR LONG!

Eligible retirees may enroll in or make changes to their medical, prescription, dental and vision benefit plan selections at any time throughout the year. Retirees are no longer restricted to the annual Open Enrollment period/deadlines.

Reminders:

- If you (your dependent) are not currently enrolled in a medical, dental, vision or prescription drug plan, you can add coverage, only if you (your dependent) were eligible for retiree benefits on the date of your retirement with proof of continuous, comparable coverage in another plan.
- If you enroll in Legal Resources, you must remain in the plan for 12 months.
- You and/or your eligible dependent must enroll in Medicare Part A and Medicare Part B when you first become eligible. Medicare will be your primary insurer and the M-NCPPC medical plans will supplement.

RSV Vaccine for Adults Covered by Caremark and SilverScript

The Centers for Disease Control and Prevention (CDC) recommends that adults 60 and older receive an RSV vaccine. Respiratory syncytial (sin-SISH-uhl) virus, or RSV, is a **common respiratory virus that usually causes mild, cold-like symptoms, including** cough, runny nose, sore throat, fatigue and sometimes fever. In serious cases, adults may experience trouble breathing or dehydration, resulting in hospitalization.

When you present your M-NCPPC Caremark or SilverScript id card at a CVS Pharmacy or Partner Retail Pharmacy such as Safeway, Giant, Walgreens or Rite Aid, your copay for the RSV vaccine will be \$0*.

*Please be advised that not all SilverScript financial systems have been updated to reflect the \$0 copay. SilverScript is monitoring their system. In the interim, if you are charged a copay (up to \$16), SilverScript will automatically generate a refund check that will be mailed to your address of record.

(Note: United Healthcare provides coverage of the RSV vaccine only for children; not adults. Kaiser Permanente members should call Member Services, 800-777-7902 for RSV vaccine coverage updates.)

Always consult with your healthcare provider before you get any vaccines.

WEEK 2—Tarragona and Valencia

We left Barcelona on the morning "regular" fast train - a little over an hour to **Tarragona**, a small UNESCO historic seaside town south of Barcelona. We spent two nights in the old part of the Roman/Gothic walled city in a charming small hotel. We visited Roman ruins - amphitheater, circus, forum, cathedral - and had lazy large late upmarket lunches and afternoon naps to sleep off too much food and wine, followed by early evening tourism - sites are open until 8 p.m.

Life is good and decadent. Salads come with tuna or other trappings from the sea - smoked fresh sardines. Flans are perfumed with coffee, and savory entrees come with small additions of red pepper or parmesan ice cream. Our 2 p.m. lunches are more than ample - we skipped dinner a couple of nights in a row - we could not possibly swallow another thing.

The coast is rocky here and dotted with bathers. There is a surprisingly busy commercial port in Tarragona with tankers and cargo ships waiting to enter the port. In the marina are several large boats and the enormous personal yachts, (the size of small ocean liners), of the Russian oligarchy. Their finishes are flawless, dustless, and void of fingerprints - buffed as if ready for a showroom. No one seems to be aboard ...perhaps seized by the Spanish government. We see one young crew member on the largest sailing vessel we have ever seen. Half of the back deck is open and we watch two people who look like the deckhand's parents, (not posh Soviets), looking down into the haul. Eventually the hydraulic hinges lower the deck flush. Perhaps crew who do not please at sea are tossed to the fishes.

We take the fast train to **Valencia** - a beautiful city of 18th and 19th Century grand historic civic buildings, mansions, and landscaped boulevards meant for strolling. Fanciful iron street lights hang from buildings and look like dangling filigree earrings. We are staying in the old part of the city. We walked the historic building tour until we could walk no more. A must-visit for Architects is the city of Arts and Science - a large modern sculpture-like development by the contemporary architect, Calatrava.

We walked through tunnels of fish at the aquarium, (the closest we will come to deep sea diving), roamed the science museum, and took in an IMAX movie on the Amazon. We continued to have dry temperate weather and breakfast alfresco. We see mostly Roman ruins in the morning. Valencia is the origin of the paella so we have a rather delicious one with cod and cauliflower for a late lunch. Our seafood-topped salad came with a cucumber ice cream/sorbet - unusual and delicious. Valencia was an important silk center starting in the 700's under Muslim rule and we visited the silk museum to learn all about it. Too full for dinner...we had peanuts and beer on one of the city's squares.

Today our travel adventures started in earnest ...a day of unexpected happenings. A lovely morning of coffee and an especially delicious croissant in a little outdoor cafe near our hotel. A walk to see the city gates and roam a small museum or two. Then the dreaded pigeon. Splat, spatter, disgust!!! Down the back of Dru's shirt, and his pants down to his ankle. In my hair and down the back of my white shirt and an appalling wet feeling on my back. Thankfully, a couple came to our rescue with a

pack of handy wipes. No number of wipes would make this right. These birds really had a load to deposit! With stiff upper lips we carried on. I tried to rinse my stained shirt out and scrub my back in a museum bathroom. We worked our way back to our stored packs, lunch, and an errand. As Dru pays for a spool of thread, he found no cash in his wallet ...gee whiz, that was an amazing amount of bird deposit that managed to hit us both...and a lot of help from such nice people ...yes, even the seasoned traveler can be had. This was truly the slickest scam and pick-pocketing we have ever experienced. We managed to restore our cash, and take our lunch. The thick man-made slime, a shade of putrid green stained all of our clothing now tossed in the trash. It was one way to reduce the weight of our packs.

We headed to the train station in fresh clothing and boarded our afternoon train to Cuenca - a World Heritage Site - a "stage set" town of medieval architecture with hanging houses that cling above deep gorges that surround the town. We have an apartment for two nights with a washing machine!


So plan your visit to Palm Springs this winter, when it's warm and sunny and you might need a change. They welcome visitors here with open arms.

The first time I heard about the Commission was seventy years ago. At that time, I was a summer employee working for a civil engineering firm located in Wheaton.

One afternoon I was sent to pick up some land records from the Commission's office, which at that time was in a two-story building located on the South side of Colesville Road and West of Georgia Avenue. The Commission's first office building was demolished to make

way for the Discovery Channel's building that opened in 2003.

The Evening Star covered the dedication of the new MRO office on September 5th 1957.





Then came the shocker last May in the form of an email informing me that the demolition of MRO was underway to prepare the site for a proposed apartment complex with over 300 rental units and retail space including a MOM's organic market.

My Commission Recollections

At age 83 and a long-time Retiree, I often recall my start with the Commission (although I don't dwell on it) and all the memories regarding my beginning, association with staff members, volunteers, Commissioners, etc. and the fantastic growth. (Time does fly). I can't remember all the names, programs, and parks, but there were many. I worked for a total of 46 years - 40 with Prince George's County and six with Montgomery County.

I graduated from Fernandina Beach High School on Amelia Island, Florida in 1957 and then attended Florida State University on a partial Track Scholarship. I was classified for military duty as 1A, thus immediately before graduating, I registered to attend the Naval Officer's Candidate School in Newport, Rhode Island. I quickly rose in rank from an Ensign, LtJG, to Lt. After serving for five years, with my last duty assignment being at the Naval Propellant Plant in Indian Head, Maryland, I resigned my Commission and circulated job applications.

Ellen Linson, Director of Recreation for Prince George's County, offered me a position as a District Supervisor, providing I pass a written test in Upper Marlboro. All prospective employees from different agencies were crowded into a room for the exam, which included questions such as: The height of a table tennis net, train A leaves a station at a certain time and speed and train B leaves another station, thus what time do they pass each other, etc. Afterwards, I negotiated an annual salary of \$8,400.

We had limited facilities, so we programmed schools and their ballfields. In the late 1960's the Commission constructed its first Community Center, known as the Prince George's Plaza Community Center which was staffed by the Recreation Department. At that time, Prince George's had five County Commissioners who sought and got legislation passed in Annapolis merging the County Recreation Department into the Maryland-National Capital Park and Planning Commission effective July 1, 1970 (best move ever). Jack Hewitt was appointed Director of Parks and Recreation for both Counties and Frank Rubini was the Deputy. Reds Robey and Barry Mangum were Associates for Prince George's and Bob Young and Carl Schoening were Associates for Montgomery.

Soon afterwards, the Commission entered a growth spurt, constructing 13 Community Centers in one year and numerous neighborhood, community, and Regional Parks in both Counties. The growth of programs and facilities never ceased thereafter. Needless to say, we encountered many hurdles, obstacles, and challenges along the way, but with the aid of dedicated staff members, volunteers, outstanding Commissioners, and political influence, the Commission succeeded. The M-NCPPC is now known nationwide as a premiere agency for its management and excellence in Finance, Planning and Zoning, and Parks and Recreation.

Whenever I gather with high school classmates or old college buddies, I always hold my head high regarding my career and the benefits provided to our retirees - Health, Dental, Vision and a monthly Defined Benefit. Northern Trust is certainly a welcome visitor on a monthly basis. Unfortunately, many of my friends can't say the same. I am positive that the majority of Retirees will agree that the Commission was a fantastic place to work. Thanks a million for all the years of enjoyment, friendship, challenges, and opportunities.
